Lakeside is authorized to make all inquiries deemed necessary to verify the accuracy of the statements made herein to determine the applicant's credit worthiness. Lakeside is authorized to contact the bank named above to release information requested for the purpose of obtaining and/or reviewing credit. Applicant(s) agree(s) to examine immediately upon receipt of material and each of Lakeside's invoices and statements, and to advise Lakeside of any disputed transactions or statements within two (2) days of receipt, together with a written statement specifying the reasons for such disputes. Failure to notify Lakeside of any dispute with respect to defective goods or billing shall constitute a waiver of all such disputes. The undersigned hereby agrees that any disputes arising out of this agreement or goods and merchandise ordered or delivered pursuant hereto will be governed and settled under applicable principles of New York law, under jurisdiction of New York Courts and that venue, in any such action, shall be chosen at the discretion of Lakeside. It is understood by signing this application I/we acknowledge and accept that a service charge of up to 2% per month, (24% per annum). A minimum of \$1.00 will be assessed on delinquent invoices, but not to at any time exceed the highest legal rate of interest allowed by law. I/We agree to pay all costs of collection, including Attorney and/or Agency, court and filing fees, whether a suit is filed. I/We have authority to bind the applicant/customer and am/are authorized by the applicant/customer to enter the credit application terms and conditions.
